Rules

1. Entries are open to any Jessamine County residents interested in growing or arranging flowers and plants, or any member of the Jessamine County Garden Club.
2. An exhibitor is limited to one entry per class.
3. Exhibits must be entered in classes as designated in class description. Only where no separate class exists may entries be made in the "Any Other" class.
4. Exhibits will be accepted between 9:00-11:30am on Monday, July 10th.
5. Exhibits will be picked up between 10:00 am on Saturday, July 15th. Any exhibit and ribbons not removed at the proper time will be disposed of.
6. The Jessamine County Fair Board or Jessamine County Homemakers Garden Club will not be responsible for loss or damage to exhibits or personal property of exhibitors.
7. Only superintendents, committee members, and judge will be allowed in Floriculture Area during judging.
8. No exhibit or part of an exhibit shall be removed from the exhibit hall prior to July 15th. Any removal will result in the forfeit of ribbons and premiums.
9. No artificial flowers or foliage are permitted in any class.
10. The decision of the judges will be final. Any errors discovered in recording of awards or placements of ribbons will be corrected by judge and/or superintendents.
11. All containers must be **GLASS** and furnished by the exhibitor. Specimens must be displayed in small clear, colorless, with no printing on glass.
12. All specimen exhibits must have been grown by the exhibitor.
13. A specimen is defined as- one flower variety on a stem. Spike, spray, or scape. **All specimen should be named.**

Awards

Where there is one entry in a class, the first prize, if merited, will be awarded. Where there is competition, all prizes, if merited, will be awarded. Where exhibits are, in the opinion of the judges, not worthy of a prize, awards will be made as the exhibits merit.

Floriculture Sweepstakes

Sponsored by the Jessamine County Homemakers Garden Club- a rosette and special award will be given to the exhibitor with the most Blue Ribbons in the Floriculture Department. In case of a tie, red and if necessary, white ribbons will be counted to break the tie.

Best Arrangement

A rosette and a special award will be given to the exhibitor in the Floriculture Division with the best overall arrangement. A \$25.00 award will be sponsored by the Jessamine County Fair Board.

Jessamine County Extension Homemaker Club Award

The Jessamine County Extension Homemakers will offer a cash award to the 3 Homemakers Clubs with the greatest number of entries (based on the percentage of club membership.) Homemakers should tell the clerks the name of their homemaker club when entering each exhibit.

5. Accessories and mechanics are permitted in arrangements but must be subordinate to the design.
6. Absolutely no artificial flowers or foliage are permitted.
